**AUTHORIZATION FORM**  
**2024 Hazardous Waste Collection Event Visitor Form**  
**Household Hazardous Waste (HHW) Collection Participation**

Occasionally, you may need access to hazardous waste collection events **not** hosted by your town or regional authority. You are a visitor. You may attend a different HHW event by registering and paying. Visitors do not live in the town or region where event is being held but live on Cape Cod. You may **not attend** an HHW event outside your town or region without authorization and payment. Authorization and payment are easy. Call the program manager.

**Steps:** Identify the HHW event that best suits your needs. Contact program manager for authorization of waste accepted and payment information.

Receive authorization and appointment from program manager.

Pay for the waste disposal by check or credit card (fees apply).

Attend your appointment on time.

Receive a receipt for payment within 7 business days.

**Who is a visitor:** Do you live on Cape Cod for ANY part of the year? Do you want to attend a HHW event not held in your town or region (refer to Table 1.0). You are a visitor. Example: You live in Eastham but want to attend an event in Yarmouth. Follow the steps noted above.

**Who is a resident?** Do you live in a Cape Cod town for ANY part of the year? If you answer 'yes,' then we consider you a resident of **the** town you spend time in. Thus, you may participate in **that** town's HHW. If that town is part of a regional HHW, then you may **also** participate in the town HHW events that collaborate. Example: Upper Cape residents have four hazardous waste collections available without registration: Sandwich, Falmouth, Mashpee, and/or Bourne; See table 1.0. **Questions? As per Department of Environmental Protection and Transportation regulations:
