Household Hazardous Waste (HHW) Collection Participation

Some trash is too toxic to trash. Did you miss your town's hazardous waste collection events? You are able to go to another town, but must register and pay. Not sure how this works? Example: Wellfleet residents are able to go to Provincetown, Truro, and Wellfleet events without registering or paying. If a Wellfleet resident wanted to attend Yarmouth, they must register and pay.

Another example: Falmouth residents are able to go to Bourne, Falmouth, Mashpee, Sandwich events with no registration or payment. If a Falmouth resident wanted to attend Barnstable, they must register and pay. See table 1.1 for regional events.

You will not be allowed to participate without filling out this form, without receiving authorization from Kalliope, and paying for your waste. NO EXCEPTIONS!
